

Greater Philadelphia Transportation Resources

Public Transportation

- **SEPTA – serving Bucks, Chester, Delaware & Montgomery Counties**
 - SEPTA offers reduced fare privileges. Application required. Privilege restricted to off-peak hours. Call SEPTA Customer Service: 215.580.7800.
 - Trained service animals ride free of charge. NOTE: The service animals must be leashed and under the owner’s control. SEPTA personnel are prohibited from taking leashes or harnesses, or interfering with duties of service animals in any way. For more information, call 215.580.3424.
- **SEPTA CCT Connect Paratransit Program (CCT):**
 - Application required. If approved, door to door service by advance registration. In order to be eligible, applicant must be functionally unable to use regular, accessible public transit. For more information, call SEPTA at 215.580.7145/610.713.2658 or www.septa.org.
- **Medical Assistance Transportation Program (MATP):**
 - This program provides reimbursement for public transit or use of private vehicle provider. Requires completion of application. Each county has its own contract with SEPTA:

- **Persons with Disabilities Program (PwD):**
 - This is a shared-ride program. Verification/eligibility application required. Check with your county regarding “On Time” requirements. Once you receive your SEPTA Shared Ride Program ID card, you may schedule trips by calling the CCT Connect reservation line one to three days in advance.

Private Transportation Options

- **Riders' Club Cooperative:**

- This is a non-profit company which provides transportation services for seniors, families and those with disabilities. Services include escorted transportation, errand services, and shopping trips. This is a membership supported organization. Services are provided primarily in Philadelphia and Montgomery Counties, and fees are charged. Contact 215.836.1376, www.ridersclubcoop.org.

- **Taxi Services:**

- There are numerous taxi companies, some of which are identified below. Medallion companies are those who pay a fee for the right to operate in their respective districts and they are subject to regulation regarding condition of vehicles, accessibility, driver licensing, insurance coverage. Additional taxi services may be located by entering Yellow Pages online, then entering "Taxis". The prompt should ask you for your location in order to locate a service provider near your location.

- **Uber/Lyft:**

- In addition, there are taxi services which recruit drivers and claim that they are acting as intermediary services between drivers and customers. These include UBER and Lyft. Transactions are conducted by cell phones applications. To use this service, download the UBER or Lyft "app" through your mobile phone.
- You will need to set up an account and enter in a credit/debit card to be charged per ride. Enter the destination address and the driver will pick you up from your home.
- A percentage of the fare paid to the driver is taken by UBER as its fee. Inasmuch as UBER states it is not a "transportation company" but merely acts as a dispatcher, it presently is not subject to regulations concerning, for example, liability coverage, accessibility and background checks of its drivers. You may be able to split your fare if there are others sharing the ride.

- **Shuttle/Bus Services:**

- These services are not geared for transporting individuals; their business is to transport small groups to larger groups, and you should contact the individual services and compare their respective services:
